The RULES**

RULES

1. Dogs must be attached to a person or in a kennel.
2. Leave the campsite neat and clean and as you found it.
3. Do not put grills on picnic tables.
4. Absolutely no drinking on trails while riding. Intoxication will not be tolerated on the trail or in camp.
5. Please take all garbage that will not burn such as bottles, cans & etc. with you!
6. Pickup after your horses & dogs!! Please dispose of hay/manure at designated area w/ supplied wheel barrow.
7. If gate is open - leave it open.
8. If gate is close - close it.
9. Riders under 18 years of age are to be accompanied by a parent or appointed guardian.
All children riding must be able to control their horses.
10. No riding double and no ponied horses.
11. Any rider unable to control his/her horse will be escorted back to camp.
12. Each participant should carry identification and an emergency telephone number.
13. No stallions allowed. No exceptions. Unruly or vicious horses of any kind will not be tolerated.
14. Inhumane or unsafe treatment of any animal will not be tolerated.
15. Any horse determined to be in an unfit condition by the Trail Boss or other ride official will not be allowed to participate in the ride for safety of both horse and rider.
16. Any rider whose horse has a tendency to kick must display a red ribbon on that horse's tail. Do not tailgate another horse.
17. The Trail Boss will lead the ride and the Drag Rider will bring up the rear. At no time should ANY rider pass the Trail Boss or fall behind the Drag Rider. Do not ride away from the group to ride on your own.
18. Trail riding is a potentially dangerous physical activity. All participants hereby acknowledge that risk and agree that in the event of any accident, neither the landowners, the committee members, the trail boss, nor any of the ride sponsors are liable, under any circumstances.

THESE RULES ARE FOR THE SAFETY, COMFORT AND ENJOYMENT OF ALL OF US. PLEASE FOLLOW THEM VOLUNTARILY; THE RIDE ORGANIZERS, TRAIL BOSS AND LAND OWNERS WILL DISMISS PARTICIPANTS FOR INFRACTIONS.
